## **Pricing:**

We make every effort to competitively maintain our prices. We do however; reserve the right to make price adjustments in response to suppliers' price increases or extraordinary circumstances. Prices are subject to change without notice. We do however, provide a thirty-day notice to our distributor network on upcoming price increases.

## **Shipping Terms:**

We appreciate every order we receive and we know how important it is for you to receive your products in a timely manner. We make every effort to ship orders out on the same day we receive a purchase order as long as it is received by 1 PM EST\*. Bottle systems and some specialty items that we carry will take longer to ship. However, we pride ourselves on exceeding your needs and will do everything possible to expedite every order we receive.

All return inquiries will be considered; however, the following conditions must be met:

- Purchasers who purchase our products from our distributors must return our products to the distributor where the product was purchased.
- All returns must be made within 45 days of purchase.

- Due to hygiene concerns, we do not accept returns if products are used and contaminated.
- We do not accept returns if a purchaser does not like the product after use.
- All returns must be accompanied by a copy of your invoice.
- Returned products are subject to a 25% restocking charge.
- All return shipping charges to our facility is the purchaser's responsibility.

In the event the item is under warranty and defective, please see "Warranty" for more details.

Please note the following exceptions:
